There have been long standing concerns about a worrying pattern of divisive community politics and alleged mismanagementofpublicmoney by the mayoral administration here Tower Hamlets. The recent and PriceWaterhouseCoopers report concludes that Tower Hamlets has failed in numerous respects to comply with its best value duty;

Hundreds of thousands of pounds in grants were handed to organisations which failed to meet even the most basic criteria to receive public money;

Property was sold without proper process and against internal advice;

Taxpayers' money was spent on unlawful political advertising for the Mayor.

The abuse of taxpayers' money and a culture of cronyism exposes a partisan community politics that seeks to trade favours. This is divisive politics – detrimental to community cohesion in Tower Hamlets.

Residents need to know that decisions are being taken properly in an open and accountable way.

The three Commissioners presently being appointed by the Secretary of State for Local Government and Communities Eric Pickles, are experienced and talented professionals, who understand that transparency and accountability are vital to the functioning of local democracy.


By taking control of grant allocation and also the sale and transfer of properties, the three commissioners will go a long way toward restoring the checks and balances lacking in our system.
